

An Analysis of the Online Transparency of New Jersey's Local Authorities and Commissions Compliance with N.J.S.A. 40A:5A-17.1

I. INTRODUCTION

In addition to having 565 municipalities and numerous boards of education, New Jersey has over five hundred other local government agencies, authorities and districts that are funded almost entirely by taxpayers. These local government agencies include fire districts, housing authorities, utility authorities, sewerage authorities and parking authorities, redevelopment agencies, soil conservation districts, improvement authorities and county park commissions.

The Legislature has given broad powers to these local agencies. They receive and spend taxpayer money just like municipalities and boards of education. They can acquire land, build infrastructure and levy taxes. They may charge fees and tolls and invest in economic development projects. Although they affect the lives of millions of New Jersey residents, most of these agencies generally operate outside of the public's attention.

In February 2011, the Office of the State Comptroller issued its study of 587 local agencies that determined the extent to which they posted pertinent information about themselves online. The Comptroller's Office reported that more than a third of these agencies did not have any online presence. Only 3 percent of them posted financial information online. The study also examined the total expenditures and total debt of 61 public agencies, which established the magnitude of their financial impact. Their total expenditures exceeded \$588 million dollars; their total debt was more than \$556 million dollars.

As a result of the Comptroller's findings, the Legislature enacted N.J.S.A. 40A:5A-17.1. For convenience of this analysis, we call this law the "online transparency law." The law applies to a wide range of authorities including soil conservation districts, workforce investment boards, county park commissions, joint insurance funds, fire districts, regional health commissions, housing authorities, municipal utility authorities, municipal development corporations and certain regional commissions such as the Meadowlands Commission, bridge commissions, water reclamation authorities, pollution control authorities, municipal port authorities and water commissions. The law became effective February 1, 2013.²

The online transparency law provides that each agency must comply with the following 11 requirements:

- 1) It must maintain an Internet website or webpage on which the following is posted:
- 2) A description of the agency's mission and responsibilities;

- 3) The adopted budget for current and two preceding years;
- 4) The most-recent Comprehensive Annual Financial Report;
- 5) The annual audit for the current and two preceding years;
- 6) The agency's rules, regulations and policy statements;
- 7) An Open Public Meetings Act notice;
- 8) Approved meeting minutes and resolutions for the current year;
- 9) Approved meeting minutes for the three most-recent years;
- 10) The name, address, email address and contact information of every person who exercises supervision; and
- 11) A list of all professionals and vendors paid more than \$17,500 or more during the preceding fiscal year.

II. BACKGROUND AND METHODOLOGY

A. The Study and the Sample

In July 2015, the New Jersey Foundation for Open Government (NJFOG) conducted a study of local agencies in order to determine the level of compliance with the online transparency law. This study is the first examination of compliance since the law was adopted. It provides a snap shot of compliance at one particular time. We recognize that agencies can make changes such as building a new website or amending information on an existing website. Notwithstanding this likelihood of change, we believe that this analysis is important because it methodically describes the nature and extent of compliance with the online transparency law.³ It is our intention to take another comprehensive snap shot of agency compliance later in 2016.

The NJFOG study selected a total sample of 436 local agencies. These are distributed among the following seven different types of public agencies.⁴ We selected these types because we believe that they have the greatest effect on the day-to-day lives of New Jersey residents. The types of agencies that were examined are:

- 1) fire districts;
- 2) housing authorities;
- 3) utility authorities;
- 4) sewerage authorities;
- 5) parking authorities;
- 6) redevelopment agencies; and

7) local authorities. These include bridge commissions and port, water-related, pollution control and incinerator authorities and one tourism commission.⁵

Table 1 shows the complete list of agencies that were examined.

B. How The Sample Was Selected

The sample was selected from two sources: The first source is the 2011 Comptroller's Report. The second source is a list of local governments that submitted budgets to the New Jersey Department of Community Affairs (NJDCA). This produced a total of 450 local agencies. NJFOG then excluded 14 agencies where there was an actual or potential conflict of interest with the local agency. For example, if a member of NJFOG's Board of Directors also held an appointed position at the local agency or was employed by a local agency, the agency was excluded from the sample. Fourteen agencies were excluded due to actual or potential conflicts of interest, leaving a total sample size of 436 local agencies. Those agencies are:

- 1) Bridgeton Port Authority;
- 2) Clementon Housing Authority;
- 3) Cumberland County Utilities Authority;
- 4) Delran Township FD #1;
- 5) Deptford Township FD #1;
- 6) Deptford Township Municipal Utility Authority;
- 7) Franklin Township FD #1 (Somerset County);
- 8) Hoboken Housing Authority;
- 9) Lambertville Sewerage Authority:
- 10) Lambertville FD #1;
- 11) Monroe Township Municipal Utility Authority (Gloucester County);
- 12) Mt. Holly Municipal Utility Authority;
- 13) Washington Township Municipal Utility Authority (Gloucester County);
- 14) Willingboro Municipal Utility Authority;

The 436 agencies that were included in the study were then classified by type:

- 178 Fire Districts. New Jersey fire districts are independent legal entities with an elected five-member governing body. They provide fire protection and conduct fire prevention activities.
- 258 Authorities and Commissions. These agencies carry out specific functions such as regulating parking or utilities. They operate on a municipal, county and regional level. Regional

authorities or commissions include multiple municipalities. The governing bodies of the agencies are appointed by the municipalities and counties that they serve. The breakdown of these agencies by number and type follows:

- 82 housing authorities
- 59 utility authorities
- 44 sewerage authorities
- 33 parking authorities
- 20 local authorities and commissions
- 20 redevelopment agencies

C. Measuring Compliance

NJFOG accepted the existence of information on an agency's website as evidence of compliance. For example, if a website had a contact name and the required accompanying information, NJFOG accepted this information as full compliance with the requirement to post the name, address, email address and contact information of every person who exercises supervision (see Page 2, Requirement 10). NJFOG did not verify whether this contact information was accurate or complete. Similarly, if the website contained at least one rule, regulation or policy statement, NJFOG accepted this as full compliance with the requirement that all of the agency's rules, regulations and policy statements be posted (see Page 2, Requirement 6). A template was then created to record the compliance findings. Table 1 shows the primary information that was collected.

III. TABLES

The findings are displayed in the following tables.

- A. Table 1 shows the ranking and compliance with each online transparency requirement for the 436 agencies that were examined. The agencies are arranged by county.
- B. Table 2 shows the 48 agencies, by county, that comply with all 11 requirements of the online transparency law.
- C. Table 3 shows the percentage of agencies in compliance with each of the 11 requirements.
- D. Table 3C also shows the percentage of agencies in compliance with each of the 11 requirements, but it has been color coded to highlight those requirements that are the most complied with and those that are least complied with. What it shows is that only three requirements have a compliance rate of 70 percent or greater. These requirements are: 1) online presence; 2) mission statement; and 3) rules and regulations.
- E. Table 4 shows the number of agencies in compliance with each requirement.
- F. Table 5 shows the number of requirements met by each agency type.

IV. KEY FINDINGS

A. Compliance with All Requirements

Only 11 percent, or 48 of the 436 agencies examined, comply with all 11 requirements of the online transparency law. Table 2 shows the 48 agencies.

B. Online Presence

Most agencies have an online presence; 412 agencies, or 95 percent, maintain a website or web page. Only 24 agencies, or 5 percent, do not have an online presence. The agencies that are most compliant are sewerage authorities, utility authorities, fire districts and housing authorities. Ninety-five percent or more of these agencies maintain an online presence. The agencies that are the least compliant are parking authorities and redevelopment agencies. Fifteen percent of these agencies do not have any online presence.

C. Three Most-Recent Budgets

The law requires that public agencies post the three most-recent budgets. Of the 436 agencies that were examined, only 241, or 55 percent, post their three most-recent budgets. Utility authorities have the highest compliance rate; 43 agencies, or 73 percent, post their budgets for the three most-recent years. Sewerage authorities and fire districts are the only other agencies that have over 50 percent compliance. Redevelopment agencies have the worst compliance record. Only four of 20 agencies, or 20 percent, are in compliance.

D. Meeting Notice

The law requires agencies to post their meeting notice online and in compliance with the Open Public Meetings Act (OPMA) (P.L. 1975, c.231). The OPMA requires that the notice show the time, date, location and meeting agenda. Only 281 agencies, or 64 percent, fully comply with this requirement. Two types of agencies have a compliance rating above 70 percent. These are utility authorities (86 percent) and sewerage authorities (80 percent). Only five of the 20 redevelopment agencies examined, or 25 percent, post notice of their public meetings that fully comply with the OPMA

E. Current Year Meeting Minutes and Resolutions

The law requires that agencies post approved minutes and resolutions for the current year. This requirement has the lowest percentage of compliance. Only 153 agencies, or 35 percent, post their minutes and resolutions for the current year. The remaining 283 agencies, or 65 percent, do not publish current minutes and resolutions. Utility authorities have the highest compliance rate of 49 percent. Only 20 percent of housing authorities and redevelopment agencies comply with the minutes and resolutions requirement.

F. Contact Information

The study found that only 266 agencies, or 61 percent, list complete contact information for at least one person. This information includes name, mailing address, email address and phone number of the appropriate supervisor. Utility authorities have the highest compliance rate. Of the 59 utility authorities studied, only 47, or 80 percent, are in compliance with the requirement. The least compliant with the contact information requirement are parking authorities. Of these 33 agencies, only 14, or 42 percent, are in compliance.

V. CONCLUSIONS

The 2013 online transparency law was intended to bring about increased transparency of local government agencies by establishing the minimum requirements for online publication. It is encouraging that 95 percent of the agencies studied have an online presence. But, as the study findings show, most agencies fall significantly short of compliance with the other requirements. They are not posting information they are required to publish and are not up-to-date. This undermines the purpose of the legislation.

VI. RECOMMENDATIONS

The law is well intentioned, but there needs to be an enforcement mechanism to bring public agencies into compliance. Currently, local agencies that submit a budget to the NJDCA are required to certify that they comply with the online transparency law. This procedure allows agencies to frustrate the online transparency law by updating their websites once a year when their budget is submitted to NJDCA.

In order to improve compliance, one option is to amend the existing 2013 law or adopt new legislation that would designate an enforcement officer within the NJDCA to oversee compliance. Another option is to incorporate into the proposed Open Public Records Act and the Open Public Meetings Act reform legislation language that would require all local agencies to maintain an internet presence and post the required basic information. By incorporating provisions into the reform legislation, the public would have a judicial remedy if agencies refuse to provide the required information

We hope that the results of the NJFOG study are considered by both the agencies we have examined and the Legislature to bring about greater online transparency and conformance with the February 1, 2013 law.
